For use on newly seeded, overseeded, or newly planted Kentucky bluegrass, tall fescue, perennial ryegrass, centipedegrass, as well as fine, spreading and creeping red fescues.

This product is for application to home lawns and applies 0.15 pounds of mesotrione per acre per application. The maximum application rate of mesotrione per treatment site per year is 0.45 pounds. This package applies 4.3 pounds of product per 1,000 sq. ft.

Apply this product before watering newly seeded, overseeded or planted grass for the first time.

New weeds will sprout white or turn white and quickly die. This product will not kill existing weeds.

#### **Use Precautions**

Do not apply this product in a way that will contact any person, or pet either directly or through drift. Keep people and pets out of the area during application. Do not enter or allow people or pets to enter the treated areas (except those involved in the watering) until the watering-in is complete and the surface is dry. Do not use this product on flowers, shrubs, trees, fruit or vegetable plants. Cana, day lilies and irises are especially susceptible to injury. Do not apply another pesticide within seven days of an application of this product as turf injury may occur. Do not apply to St. Augustinegrass, bentgrass, bermudagrass, zoysiagrass, dicondra, kikuyugrass, bahiagrass or lippia.

#### **Application Instructions**

Apply on a calm day and lightly water to activate. Apply when temperatures are consistently between 60°F and 90°F. Avoid applying to adjacent flower beds when using a rotary spreader.

This product may cause temporary whitening of grass foliage. In general, symptoms appear five to seven days after application and may last up to 14 days. Discoloration is most likely to occur on ryegrass lawns.
